That I am 18 years of age or older and will be engaging in activities that involve risk of serious injury, including permanent disability and death, and severe social and economic losses which might result not only from my own action, in---actions or negligence but also others, the rules of play, or the condition of the premises or of any equipment used. Further, that there may be other risks not known to me or not reasonably foreseeable at this time.

That I knowingly and freely assume all the foregoing risks and accept personal responsibility for the damages following such injury, permanent disability or death.
